

## **DERIVED MEMBERSHIP APPLICATION FORM GUIDE:**

This guide does not form part of the Derived Membership Application Form but is designed to clarify what Derived Memberships are and assist you in completing the Derived Membership Application Form.

### **Definition of Derived Membership:**

Constitution: Article 4: Membership of Association:

(f) Syndicate/Partnerships – The MHAA recognize syndicates and partnerships in the ownership/lease of registered horses. (As these are Derived Memberships and have no voting rights) National Committee has affirmed that all Members of those syndicates and partnerships MUST individually be Members of MHAA (a once only Prefix Registration Fee is payable if that is required by the Members of these Syndicates & Partnerships to formally register & record their joint interest in the horses.

### **Prefix & Brand:**

A Derived Membership is the principal owner of the Brand and Prefix and cannot be transferred if Members of the Derived Membership cancel this Membership. The Brand and Prefix remain with the lapsed Derived Membership.

### **Fees:**

For new Members: Full Membership Fee \$100.00 per Member of Syndicate/Partnership, plus \$22.00 per Member of Syndicate/Partnership for initial set up of Derived Membership.

For existing Full Members: Payment of \$22.00 per Member of Syndicate/Partnership for initial set up of Derived Membership.

For existing Members who are part of a Family or Joint Membership: These Members will have to change their class of Membership to a Full Membership and in addition pay \$22-00 per Member of Syndicate/Partnership for initial set up of Derived Membership.

On renewal of Membership: Full Membership Fee per Member \$100.00, plus Annual Fee \$22.00 for Derived Membership (not per Member).

### **Completing Application Forms:**

For new Members: Complete Membership Application and Derived Membership Application Forms and submit together with correct fees (see Forms for details).

For existing Full Members: Complete Derived Membership Application Form and submit with correct fees (see Form for details).

For existing Members changing class of Membership: Complete Membership Application and Derived Membership Application Forms and submit together with correct fees (see Forms for details).

On renewal of Membership: Complete Membership Renewal and Derived Membership Application Forms and submit together with correct fees (see Forms for details).

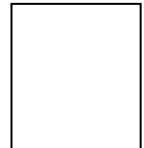
