Dear Members,

Taking into consideration the feedback from Members, National Committee have extended the Amnesty on Revoked Horses until 31 December, 2016. Therefore, if you have a Horse that is in revoked status, i.e. over 4 years 6 months old and has not been Upgraded to Permanent Adult, you can upgrade the Horse without paying the extra Revoked Fee. National Committee hope this will assist Members who have been unable to upgrade their Horses when due. If you have any queries with regard to this Amnesty, do not hesitate to contact us.

We have been contacted by several Members lately who have Registrations to bring up to date, or Horses to register and who have felt it is all too hard and were told by "someone" that it was going to cost too much, or that some of their Horses couldn't be registered as previous owners had not kept their paperwork up to date. In all cases we have been able to assist these Members and either Register or upgrade their Horses, also at far less cost than they had expected.

So, if you are behind with your paperwork and/or have any registrations or upgrades that you are concerned about, or not sure of the best way to go about bringing them all up to date as it all seems overwhelming, don't hesitate to contact us, as most of the time there is a way to work through them, one by one and assist you in getting them up to date.

Members are reminded that Membership Renewals are now OVERDUE and that if you have not renewed your Membership you cannot Register or Upgrade any Horses, or exhibit at any Shows.

We have had excellent feedback from Members with Membership Renewals now being able to be done on online and paying via EFT and would like to take this opportunity to remind Members if they do pay via EFT, please remember to email your On Line Membership Renewal Form to the office via the email address accounts@mhaa.com.au
